Example Training options include:

## Electric Utility-Related:

- ↳ Line worker training – *workshops provided by state municipal utility associations (Kansas Municipal Utilities (KMU), Iowa Association of Municipal Utilities (IAMU)), or approved Community College course*
- ↳ Line worker correspondence course - *4-year course - “Merchant Job Training and Safety Program”*
- ↳ Power plant operator training - *Power plant training programs sponsored by your state utility section/association*
- ↳ Refresher utility course - *Meter schools - 2- and 3-day lineworker schools*
- ↳ Safety training - *Safety training programs sponsored by your state utility section/association*
